WHEREAS, we are proudly pro-peace, and pro-humanity. That is why we are proudly demanding a lasting ceasefire and an end to violence; and

WHEREAS, we understand that the Palestinian people are not Hamas; and Israeli people are not the Israeli Defense Forces; and

WHEREAS, all people deserve to live without fear, hunger or death brought upon by war; and
